Introduction

Flow control is in the form of a pressure reducing valve located on the discharge side of each pressure pump. Theses valves limit the flow of treated water and prevents the distribution flow rate from exceeding the permitted flow rates. Average flow rate when pumps are operating is 120 litres per minute.
