### <u>Introduction</u>

Schedule 22 of O. Reg 170/03 requires the preparation by the water system owner of a "Summary Report for Municipalities." This requirement only applies to large and small municipal residential systems. The Waldemar Heights Water Supply System is classified as a Large Municipal Residential Drinking Water System.

The Summary Report for the preceding year is to be issued by March 31 of the following year. This report was prepared by Dufferin Water Co. Ltd on behalf of the Township of Amaranth.

Distribution of the Summary Report is the responsibility of the owner. For a municipality that owns the water supply, all members of council are to receive the report. If the water system is owned by a municipal service board established under Section 195 of the Municipal Act, 2001 then all members of that board are to receive the report. Finally, if a water supply provides water to another municipality under contract, then the water supply owner shall, give by March 31 a copy of the Summary Report to the Municipality being supplied.

- 2. A list of the requirements of the water system's permit that the water system failed to meet during the report period, including the duration of the failure.
- 3. A list of any Orders that the water system failed to meet during the report time frame, including the duration of the failure.
- 4. For each of the above failures, a description of the measures taken to correct the failure.
- 5. A summary of the quantities and flow rates of water supplied "including monthly average, maximum daily flows, and daily instantaneous peak flow rates." (Information is to enable the owner to assess the capability of the water system to meet existing and future demand).

A statement that captures the comparison of the flow information to the rated capacity and flow rates stated in the water supply's approval.

Flow control is in the form of a pressure reducing valve located on the discharge side of each pressure pump. Theses valves limit the flow of treated water and prevents the distribution flow rate from exceeding the permitted flow rates. Average flow rate when pumps are operating is 120 litres per minute.
